



# Ground Investigation works, Cappers Lane area, Network Rail land

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we will be doing

We will be undertaking ground investigation surveys on land belonging to Network Rail, near Cappers Lane. These surveys help us to understand more about the ground conditions where we will build the railway. The surveys will involve taking soil samples and boring trial holes in different locations. We will be transporting our equipment on the railway track.

These works will take place overnight for 2 weekends

21-22 August 2021 from 10:30pm – 9:00am 1 night (Saturday)

28-29 August 2021 from 11:30pm – 7:30am 1 night (Saturday)

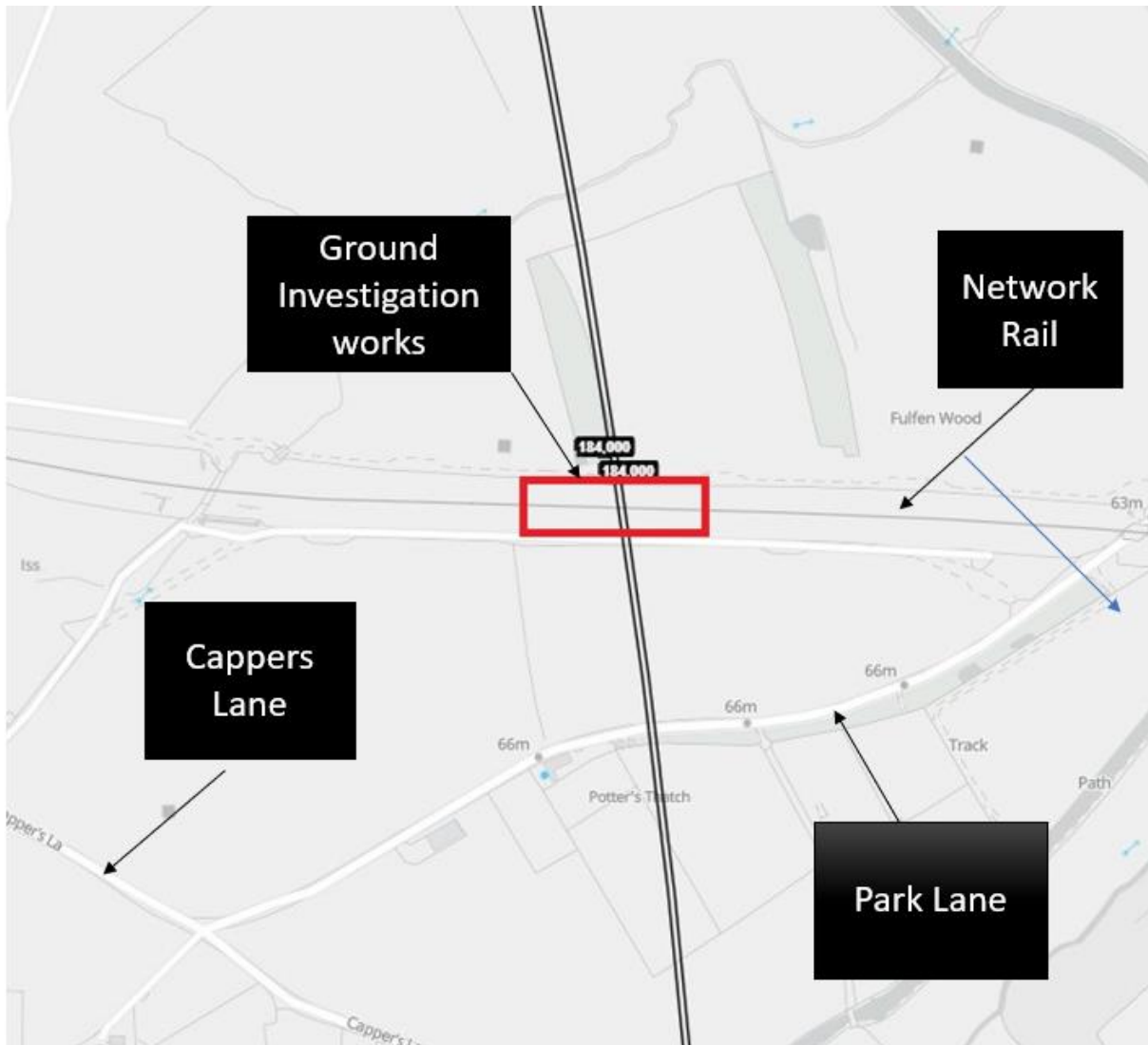
