High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

To maintain a safe area for construction staff, there will be a temporary closure of Park Lane.

These works are required to create two new entrances to our compound.

The work undertaken will include preparation of the road edges and laying of new kerb stones.

Within our compound area, we will construct a haul road which will be used by our construction vehicles. Haul roads are temporary roads provided within a working area to allow for the movement of construction material, construction machinery and/or construction staff around the site. Haul roads are Balfour Beatty Vinci's preferred logistical transport link, as they reduce the number of vehicles interfering with the existing local road network and provide the greatest possible control over works activity.

When we will do these works

From 8:00am on Monday 27 September 2021 until 6:00pm Friday October 8 2021, with an hour before, and an hour after to set and take down our equipment.

There will be a diversion in place - see the map.

These works will take place from 8:00am on Monday 27 September 2021, until 6:00pm on 8 October 2021, with an hour before and an hour after to set up and take down our equipment.

The road will be closed for the duration of these works.

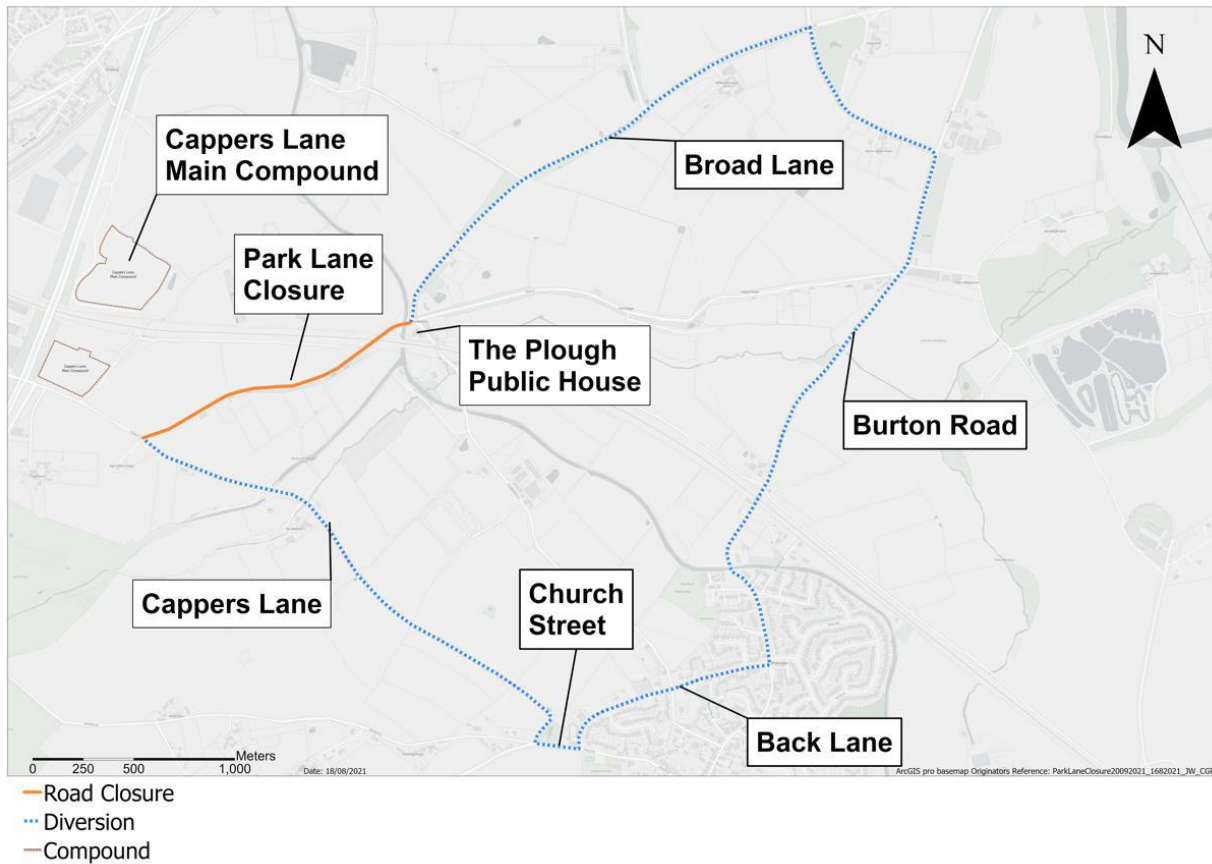
