



Notice of survey works at Wood End Lane, Lichfield

High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Balfour Beatty is carrying out surveys and investigating ground conditions along the Phase 2a route.

What we are doing

HS2 Ltd is proposing changes to the junction of the A515 and Wood End Lane, with further widening to Wood End Lane itself. This is to improve traffic flows during the construction of HS2. To help design the changes to the highway, Balfour Beatty will carry out various surveys and ground investigation works starting late September. Initially, we will work in the fields surrounding Wood End Lane between the A515 junction and the junction with Watery Lane. This work will involve “non-intrusive” walkover surveys to collect environmental data.

Following this, we will begin some “intrusive” surveys in the fields along the A515. These will involve some trial pit excavation and drilling.

During October and November, we will carry out both “non-intrusive” and “intrusive” work at the A515/Wood End Lane junction. We will need to put some traffic management measures in place to carry out this work safely. We will provide further information about this work once we have finalised the details. When planning this work, will work hard to reduce the impact on residents and stakeholders.

How we will minimise disruption

We will aim to minimise the impact to local people. We will install sound barriers around the perimeter of the drilling equipment to reduce noise levels.

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government’s current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.



Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
